FOR CONTINUING COMPLIANCE/UNDERTAKING:

A. LICENSE TO OPERATE

- 1. The LTO shall be signed by the owner/operator and posted in a conspicuous place where establishment is located.
- 2. The LTO shall be renewed within sixty (days) before its expiry date.

B. OPERATIONS

- 1. The operator shall pay to NMIS the 25% of the total meat inspection fee (ante-mortem and post-mortem fee) every 10^{th} day of the succeeding month.
- 2. The operator shall comply with the regulations relative to adoption of GMP/SSOP/HACCP in the operation of the meat establishment (DA AO 21. s2004 and DA AO 09. s 2003) and implement at all times during operation.
- 3. The Operator shall allow access to the meat inspection officer/s at all times whether the meat establishment is in operation or not.
- 4. The Operator shall only accept slaughter animals with accompanying Veterinary Health Certificates and Shipping Permits.
- 5. All food animals unloaded within the meat establishment premises shall be treated as slaughter animals and shall not be allowed to be taken-out for transfer back to its farm or to other meat establishment premises.
- 6. The Operator shall comply with the provisions of DA Administrative Order No. 18, series of 2008, to ensure the adequate protection and welfare of food animals awaiting slaughter.
- 7. The Operator shall have the responsibility to maintain meat establishment in good operating condition at all times and to comply with the meat hygiene and inspection regulations.
- 8. The Operator shall not allow any person withdraw and transfer any carcass or stored carcass, or any of its parts to other destinations without the corresponding Meat Inspection Certificate/s issued by NMIS Plant Officer/Meat Inspector or Deputized Meat Inspector/Meat Control Officer.

C. RECORD KEEPING

1. The operator shall keep and maintain records, reports and information, and shall fully and correctly disclose all transactions in the operation of the establishment relative to meat safety and quality assurance. Such records and information shall be made available upon the request of the NMIS MSQA Auditors for monitoring, validation, and verification purposes.

D. COORDINATION

- 1. The operator shall notify officially the concerned NMIS Regional Technical Operation Centers (RTOCs) regarding any plan of changes in facility or operations for technical assistance and approval.
- 2. The operator shall maintain compliance to RA 9296; RA 10536; RA 10611 and other pertinent meat inspection laws, rules, and regulations of the Department of Agriculture and all other applicable laws.

E. OTHERS

1. The LTO shall be automatically cancelled should **DENR issue Closure Order** or upon lapse before one year whichever comes first.

GROUNDS FOR SUSPENSION/REVOCATION

- 1. Non-renewal of License to Operate (LTO) will mean recall of NMIS Plant Officer and documents/paraphernalia related to inspection and issuance of certifications. Transport of finished products beyond the city or municipality shall not be allowed.
- 2. Failure by the Operator to comply with the above-stated conditions and requirements shall result to suspension or revocation of this License to Operate (LTO) after due process.
